No. 50, Environment and Forest (FR.2) Department, dated 09.04.2015, wherein relief has been granted to the petitioner/respondent herein, by counting 50 percent of the service rendered by him as Plot Watcher on daily wages along with the regular service rendered by him as qualifying service and eligible pension and other consequential benefits have also been granted to him.

2. In view of the above, nothing survives for further adjudication in the Writ Appeal. Consequently, the writ appeal stands dismissed as infructuous. Consequently, connected W.M.P. is closed.
