We have heard Mr.Adinarayana Rao, learned counsel for the petitioner; Mr.P.Muthukumar, learned State Government Pleader, assisted by Mrs.R.Anitha, learned Special Government Pleader for respondents 1 to 5; and Mr.T.Amargirish, learned counsel for the sixth respondent.

2. A status report is filed by the Tahsildar. As per the status report, the subject Survey No.70/2 has been inspected. The same is a pond (Kuttai) and encroachment is found constructed by the sixth respondent. It is stated that Form Nos.I and II would be sent to the Block Development Officer under the Tamil Nadu Land Encroachment Act, 1905 to remove the encroachment as per law.

3. As it is stated in the status report that the process of law will be undertaken, the respondent authorities are directed to take appropriate steps expeditiously. The writ petition is disposed of
