Since Mr.Sajeev Kumar would accede to the receipt of the representation aforesaid and he would also have no objection to a direction being issued to R1 fixing a time frame for disposal of the same, mandamus is issued to R1 to issue notice to the petitioner within a period of two (2) weeks from today fixing the date of personal hearing, hear it and pass orders on the representation dated 28.03.2023 within a period of four (4) weeks from date of personal hearing, in accordance with law.
