**Prayer in W.P.No.5782 of 2014:** Writ Petition filed under Article 226 of Constitution of India, to issue a writ of Certiorarified Mandamus, calling for the entire records of the 2<sup>nd</sup> respondent in the impugned award No.2/2013 Na.Ka.D1.48478/ 2009 and to quash the same or in the alternative pleaded to



direct the respondents herein to change alignment by widening 1½ meter on the northern side of the road or opposite to the petitioner Hotel wherein the petitioner is owning land and building in so far as the petitioner is concerned.

**Prayer in W.P.No.11067of 2014:** Writ Petition filed under Article 226 of Constitution of India, to issue a writ of Certiorarified Mandamus, calling for the entire records of the 2<sup>nd</sup> respondent in the impugned award No.2/2013 dated 23.12.2013 and to quash the same in so far as the petitioner is concerned or in the alternative passed to direct the respondents herein to change the alignment by widening 1 ½ meter on the northern side of the road or opposite to the petitioners' residential bungalow.

### **COMMON ORDER**
