This Criminal Original Petition is filed to direct the 2nd respondent to give police protection based on the petitioner's complaint dated 03.05.2023.

2. The Learned Counsel for the petitioner submits that, the petitioner herein and the 3rd respondent have dispute over the property. In this regard, complaint has been given on 03.05.2023, alleging that, the 3rd respondent is preventing the petitioner from enjoying the property and also threatening him.
