ORDER

(Order of the court was made by the Hon'ble Chief Justice)

We have heard Mr.P.Chandrasekar, learned counsel for the petitioner; Mr.K.Karthick Jeganath, learned Government Advocate for respondents 1 and 2; Mr.P.Emayavaramban for M/s.Ramalingam Associates, learned counsel for respondents 3 and 4 and Mrs.M.Sneha, learned counsel for the fifth respondent.

2. Learned counsel for the petitioner submits that the respondents are not implementing the regulations as per the Government Order bearing G.O. (Ms) No.435 dated 30.09.2019 issued by the Health and Family Welfare Department. They are not collecting proper fee for scrutiny of the proposals submitted by the Self-Financing/Private Institutions to start Paramedical Allied Health Science Courses and also not performing their duties by inspecting the infrastructure of the said proposed colleges and thereby proper education is not imparted.
