2. When the matter is taken up for hearing, it is represented that both parties are before this Court by means of A.S. No. 668 of 2020. It appears that the respondents in the contempt petition have disobeyed the interim order dated 04.08.2020 passed by this Court in view of the fact that the said order was not extended.
