The petitioner, wife of the detenu, namely Saravanan @ Sembetti Saravanan, Male aged 32 years, S/o.Kannaiyan, has come forward with this petition challenging the detention order passed by the 2nd respondent dated 15.06.2023 slapped on her husband, branding him as "Bootlegger" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug

Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].
