ORDER

On completion of the enquiry, the respondent Police shall take a decision regarding the further course of action. This process shall be completed by the respondent Police within a period of two (2) weeks from the date of receipt of copy of this order.

With the above direction, this Writ Petition is disposed of. No costs.
