ORDER

Ms.Nivedha, representing counsel for the petitioner, states that the petitioner has passed away pending writ petition and the counsel are unable to contact the legal heirs. 2.Mr.Veda Bagath Singh, learned Special Government Pleader, who appears for R1 and R2 would assure the Court that while there was a tentative proposal in 2014 as
