Now, the Writ Appeal was also disposed of, by an order dated 04.06.2019 in W.A.No.2058 of 2013, since the benefits which were ordered in W.P.No.7011 of 2007, dated 12.08.2011 was granted to the respondent therein.

4. In view of the above, the respondents 2 and 3 herein are directed to consider the representation submitted by the petitioner and pass orders, in view of the order passed in W.P.No.7011 of 2007, dated 12.08.2011, within a period of eight weeks from the date of receipt of a copy of this order.
