ORDER

This Criminal Original Petition has been filed directing the learned Principal Sessions Judge under SC/ST (POA) Act Cases, Salem District to consider the bail application filed by the petitioner on his surrender in connection with Crime No.59 of 2022 registered for the offences under Sections 417, 376(2)(n), 312, 294(b), 496 and 506(ii) of IPC r/w Sections 3(1)(s), 3(2)(v) of the SC/ST (Prevention of Atrocities) Amendment Act, 2015, on the file of the second respondent police on the same day.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the learned Principal Sessions Judge under SC/ST (POA) Act Cases, Salem District, to consider the petitioner's bail application, in connection with Crime No.59 of 2022 pending on the file of the second respondent police and pass appropriate orders in accordance with law, after affording due opportunity to the victims under Section 15-A of the SC/ST (POA) Act, 1989. The petitioner shall surrender before the concerned Jurisdictional Court, within a period of fifteen days from the date of the receipt of a
