2.Heard the learned counsel for the petitioner, learned Special Government Pleader appearing for the respondents 1 to 3 and learned counsel for the respondents 4 and 5.

3.Considering the limited nature of relief sought for in this Writ Petition, this Court, without going into the merits of the case, directs the respondents 1 to 3 to consider the petitioner's representation dated 16.12.2017, if not considered earlier and pass appropriate orders, on merits and in accordance with law, after affording an opportunity of hearing to all
