ORDER

By consent, this writ petition is taken up for final disposal at the admission stage itself.

2.The petitioner has filed this petition, seeking a direction against the respondents /TANGEDCO to shift the electric motor from the old well to the new well, which is pending with the authority since 24.02.2023.

3.Mr.D.Sureshkumar, the learned Standing Counsel for TANGEDCO, makes a statement on instruction, stating that the petitioner has merely given a representation without the necessary accompanying documents.

Once this is done, the petitioner is required to give a fresh representation with all necessary documents. On receipt of the same, the 1st respondent is directed to make a decision within a period of six (6) weeks from the date on which the petitioner presents his fresh application within the framework of the law.
