2.However, Mr.P.Baladhandayutham, learned Special Government Pleader appearing for the respondents 1 to 3, on instructions,

submitted that, transfer counselling has been conducted and the petitioner has also participated in the counselling and as per his request, he has been transferred to Nallagoundampalayam Village and the petitioner has joined duty in the new place on 03.07.2023 and is now working in Nallagoundampalayam Village.

When the petitioner himself has participated in the general transfer counselling and has been transferred to a new place as per his request, nothing survives for further consideration in this writ petition. Hence, this writ petition is dismissed. No costs. Consequently, connected miscellaneous petition is closed.
