2. Today, when the matter is taken up for hearing, learned Standing Counsel appearing for the respondent Municipality would state that already lock and seal notice was issued in respect of unauthorised construction and enforcement action has also been initiated.

In view of the above stated position, the 1st, 2nd & 4th respondents are directed to take further enforcement action in accordance with law and take it to its logical end within a period of eight weeks from the date of receipt of a copy of this order. Accordingly, the Writ Petition is disposed of. No costs.
