ORDER

2. The case of the petitioner is that the petitioner was appointed as B.T. Assistant [Social Science] in the fifth respondent school with effect from 01.06.2020 in the vacancy arising out of the retirement of one Mrs.Josephine Mary on 29.02.2020. The fifth respondent forwarded the

5. In view of the submissions on either side, the first respondent is directed to pass Orders on the proceedings of the fifth respondent on its own merits within a period of two months from the date of receipt of a copy of this Order.
