2. Pending the writ petition, learned counsel for the writ petitioner/management as well as the learned counsel for the workman have arrived at an agreement that if amount of Rs.4,10,000/- is paid, it will be treated as satisfaction in C.P.No.841 of 2007. They have also made

W.P.No.22528 of 2014 stands closed, since the writ petitioner and the respondents have agreed to receive a sum of Rs.4,10,000/- in full quit of the amount dues.
