Court in W.M.P.No.10948 of 2016 in W.P.No.8302 of 2016, dated 03.11.2016, the Food Corporation of India (South Zone) had preferred a writ appeal in W.A.No.1446 to 1457 of 2016, in which the Division Bench of this Court, vide order dated 16.11.2016, had allowed the writ appeals by setting aside the said interim order dated 03.11.2016 and dismissed the main writ petitions itself, granting liberty to the petitioners/employees to workout the remedy in the manner known to law and subsequently, contempt petition in Cont.P.No.2524 of 2018 was filed for non-compliance of the order passed in the said writ appeals, which was also disposed of on 11.03.2021.

3. In view of the above, no further order is necessary in these writ petitions. Accordingly, these writ petitions are dismissed. No costs. Consequently, the connected miscellaneous petitions are closed.
