Prayer in WP.8768/2016:- Writ petition filed under Article 226 of the Constitution of India praying for issuance of a writ of Certiorarified

Mandamus, to call for the entire records pertaining to the letter of rejection issued by the 3rd respondent dated 27.11.2014 and quash the same consequently, direct the respondents to re-convey the Title of the petitioner's land to an extent of 61 cents in S.Nos.439/B1 and 439/B2 at Thanigaponur Village, Vellore District receiving the sale consideration as per the current guide line value.

Prayer in WP.8769/2016:- Writ petition filed under Article 226 of the Constitution of India praying for issuance of a writ of Mandamus, to call for the entire records pertaining to the letter of rejection issued by the 3rd respondent dated 27.11.2014 and quash the same consequently, direct the respondents to re-convey the Title of the petitioner's land to an extent of 2 Acre 67 cents in S.Nos.431/A1, 431/A2, 431/A3, 431/A4, 431/A5, 433/A2, 437/4, 437/7 and 96 cents in S.Nos.438, 439/A, 441/1, at Thanigaponur Village, Vellore District receiving the sale consideration as per the current guide line value.
