No.413/2012/Q3, dt. 19.11.2013, as confirmed by the impugned order of the 2nd respondent bearing R.C. No.3325/MM9/2014, dated 29.09.2015 and as confirmed by the impugned order of the 1st respondent bearing G.O. (D) No.86 Industries (MMC-2) Dept., dt. 18.06.2019 pertaining to the licensed stockyard of the petitioner measuring 1.10.5 Hec. comprised in S.F. Nos.212/1C & 213/6,

Nos.212/1C and 213/6, situated in Ilayanarvelumathura Vallimedu Village, Kanchipuram Taluk, Kanchipuram District.
