The petitioner challenges the impugned order of detention in C.No.23/G/IS/Tiruppur City/2023 dated 12.06.2023 detaining his brother as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

2. Learned Additional Public Prosecutor for the respondents submits that the order of detention has been revoked by the Advisory Board vide G.O.Rt.No.4049, Home, Prohibition and Excise (XII) Department dated 26.07.2023.
