ORDER

The petitioner is the widow of Late.Raju @ George Raju and complaints that her son has obtained a legal heir certificate excluding her name and has indulged in certain activity affecting her right to property. The petitioner now requires a legal heir certificate including her name as the legal heir of Late.Raju @ George Raju.

2.Mr.V.Manoharan learned Additional Government Pleader appeared for the respondents 1 and 2 and submitted that the petitioner has to prefer a representation to the Revenue Divisional Officer, Ambattur to rectify or cancel the legal heir certificate already issued.

3.This Court *suo motu* impleads the Revenue Divisional Officer, Ambattur, Chennai – 600 040 as the fourth respondent.

4.The Registry is required to carry out necessary amendments in the

6.The Writ Petition is disposed of accordingly. No costs.
