2.The learned counsel for the petitioner submitted that the petitioner was granted bail in CrI.M.P.3974 of 2023 on 20.06.2023 by the learned Principal Special Court Judge under EC & NDPS Act, Chennai. While granting bail, the learned Principal Special Court Judge under EC & NDPS Act, Chennai, directed the petitioner to produce two acceptable and reliable sureties. One among them shall be a Government Servant. Petitioner is not able to secure a Government Servant as a surety.

3.Considering the submission of learned counsel for petitioner, this Court modifies the condition imposed by learned Principal Special Court Judge under EC & NDPS Act, Chennai, as follows: “Petitioner shall produce two acceptable and reliable sureties for executing a bond for Rs.10,000/- each to the satisfaction of learned Judicial Magistrate, Tambaram”. Other conditions remain same.

4.Accordingly, this Criminal Original Petition is allowed.
