ORDER



This petition has been filed seeking a direction to the learned Sessions Judge, Special Court for Exclusive Trial of Cases registered under the SC/ST (POA) Act, 1989, Villupuram, to accept the surrender of the petitioner herein concerned in Crime No.270 of 2023 on the file of second respondent and consider the bail petition on the same day itself.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of two (2) weeks from the date of receipt of a copy of this order and on such surrender, the learned Sessions Judge, Special Court for Exclusive Trial of Cases registered under the SC/ST (POA) Act, 1989, Villupuram, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
