This case is taken up for settlement before the National Lok Adalat. Both the parties are present. Mr.K.J.Sivakumar learned counsel for appellant/Transport Corporation and Mr.K.Varadha Kamaraj, learned counsel for the respondent is present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:



TERMS OF SETTLEMENT

The Tribunal has awarded a sum of Rs.2,88,100/- with interest at 7.5% per annum from the date of numbering of petition till the date of realisation as compensation. Aggrieved by the award of the Tribunal, the appellant / Transport Corporation had preferred the present appeal.

2. After due deliberation and consultation, both the parties have agreed to modify the award to a sum of Rs.3,75,000/- (Rupees Three Lakhs Seventy Five Thousand only) in full quit (inclusive of interest) as compensation.

3. The appellant /Transport Corporation is directed to deposit the above said accepted award amount of Rs.3,75,000/- (Rupees Three Lakhs Seventy Five Thousand only), after deducting the amount already deposited if any, within a period of eight weeks, under two instalments from the date of receipt of a copy of this award. If the payment has not been made within the time stipulated, the appellant is directed to pay the amount along with the interest at the rate of 6.5% till the date of realisation.

4. On such deposit, the claimant/respondent is permitted to withdraw the modified amount without filing any formal petition.

5. The Tribunal is directed to transfer the amount through RTGS/NEFT to the parties concerned on proper identification in accordance with the terms of the award, with out insisting on any formal permission petition. The Civil Miscellaneous Appeal is disposed of accordingly.



This Lok Adalat award is passed in terms of the above settlement.
