ORDER

The petitioner/wife seeks transfer of H.M.O.P.No.24 of 2023 pending on the file of Subordinate Court, Veda sandur, Dindigul to Subordinate Court, Ambattur, Tiruvallur.

2. Despite service of notice, there is no representation on the side of respondent.

The learned counsel for petitioner would submit that the petitioner wife seeks transfer of the proceedings on the ground that she is not able to travel from her place of residence to attend every hearings before the Subordinate Court, Veda sandur, Dindigul. Hence, he prayed to transfer the petition.

3. Records perused. The reasons assigned by the petitioner wife is justifiable one and the fact that she is not able to travel from Chennai to attend every hearings before the Subordinate Court, Dindigul. No costs. Consequently, connected civil miscellaneous petition is closed.
