This petition has been filed to modify the condition that the petitioners shall deposit a sum of Rs.80,000/- (Rupees Eighty Thousand only) each to the Dean/Medical Officer, Government Medical College and Hospital, Coimbatore, which is imposed in Crl.O.P.No.13920 of 2023 dated 28.06.2023.

2. The learned counsel for the petitioners submitted that this Court, by an order dated 28.06.2023, had granted bail to the petitioners in Crl.O.P.No.13920 of 2023 with a condition to deposit a sum of Rs.80,000/- (Rupees Eighty Thousand only) each to the Dean/Medical Officer, Government Medical College and Hospital, Coimbatore. He further submitted that despite the best efforts, they were unable to raise the huge amount. Thereby, he seeks for modification of the condition.

3. Heard both sides.

4. Taking into consideration the facts and circumstances of the case, the submissions made by the learned counsel on either side, this Court is inclined to modify the Condition (Paragraph 7), which shall be read as follows:-

“ 7. Accordingly, the petitioners shall make a non-refundable deposit of a sum of Rs.50,000/- (Rupees Fifty

Thousand only) each directly to the Dean/Medical Officer, Government Medical College and Hospital, Coimbatore and on such deposit and production of proof, the petitioners are ordered to be released on bail in the event of arrest or on their appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned Judicial Magistrate, Avinashi, on condition that the petitioners shall execute a separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:”

The other conditions imposed by this Court in CrI.O.P.No.13920 of 2023 on 28.06.2023 shall remain unaltered. Further period of two weeks time is granted to the petitioner to surrender and execute sureties before the concerned Magistrate as imposed by this Court, from the date on which the order copy made ready. Failing which, the petition for anticipatory bail shall stand automatically dismissed and no further extension will be granted.
