On receipt of the same, the Principal District and Sessions Judge, Thiruvallur, shall proceed further and all steps shall be taken to complete the proceedings as expeditiously as possible. The learned Judicial Magistrate, Thiruvottiyur, shall file a compliance report on complying with the above direction.
