ORDER

At the time of admission of this writ petition, this Court directed the first respondent to refer the complaint to the Revenue Divisional Officer concerned to initiate proceedings under Section 107 of Cr.P.C. Accordingly, it was referred before the Revenue Divisional Officer, Mettur and the enquiry is pending in LAR.No.18 of 2021. However even till today, enquiry is pending.
