Writ Petition is filed under Article 226 of the Constitution of India to issue a writ of mandamus directing the respondents to order for payment of balance daily rated salary from 22.01.1988 and consolidated wages from 01.03.1988 and scale of pay of Rs.800-15-1010-EB-20-1150 from 29.08.1988 further grant pay scale of Rs.950-20-1150-EB-25-1150 from

21.10.1988 further direct the respondents to pay yearly bonus, Earn Leave and Medical leave for the period of 9 years from 29.08.1988 to 08.09.1997 and further direct the respondents to pay Actual monetary Benefits in post of Supervisor Grade-II from 03.12.1997 to 25.04.2012 further promote him to the post of Supervisor with monetary benefits from 03.12.2002 and promote the petitioner to the post of Assistant Development Officer from 03.12.2007 and promote the petitioner to the post of Development Officer from 03.12.2012 with all consequential monetary and other benefits on the basis of the petitioner's representation dated 30.06.2021.

ORDER

This Writ Petition has been filed for the issuance of a writ of mandamus directing the respondents to promote the petitioner to the post of Development Officer and to grant other benefits including arrears of backwages and all consequential monetary and other benefits.

2. The petitioner who claims for his promotion as well as other

benefits including arrears of backwages and pending claims, has given a representation to the respondents on 30.06.2021. Since the said representation has not been considered and no order has been passed so far, I feel the respondents should be directed to consider the representation and pass order within a time frame.

3. Accordingly, this Writ Petition is disposed with a direction to the respondents to consider the petitioner's representation dated 30.06.2021 and dispose the same in accordance with law, within a period of six weeks from the date of receipt of a copy of this order. No costs.
