It is the grievance of the writ petitioner that the seventh respondent who is the husband of the sixth respondent/Village President has locked the Village Poverty Reduction Committee (VPRC) building, wherein, meetings of Magalir Thittam are being conducted. In this regard, he has sent a representation dated 27.06.2022 to the respondents 1 and 2 which are pending without consideration till date. Hence, this writ petition.

3. Heard both sides and perused the materials placed on record. The photographs are also filed before this Court in the typed-set of papers to show that the buildings are kept locked. Such view of the matter, this Court directs the first respondent to consider the representation of the petitioner dated 27.06.2022 and pass order(s) on its own merits and in accordance with law within a period of one month from the date of receipt of a copy of this Order.

4. Accordingly, this writ petition stands disposed of. No costs.
