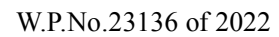

ORDER

With the consent of both the parties, this Writ Petition is taken up for final disposal.

2. The petitioner herein, who was serving as Senior Assistant under the respondent Corporation, had voluntarily retired from service on 30.06.2019. However, her retirement benefits (PF, Gratuity, EL Salary) came to be settled only on 22.01.2021. The petitioner had given a representation on 08.06.2022, seeking for interest on the belated payment of the retirement benefits and also to pay the unsettled benefits like ERBS Pension Amount, EL Surrender and IRT Share amount from 01.07.2019 with interest, which is yet to be considered.

3. This Court, in various decisions, have already taken a view that in all cases of belated payment of the terminal benefits, the concerned employee would be entitled for interest at the rate of 4% per annum. In this background, this Court is of the view that the petitioner would be entitled for interest at the rate of 4% per annum on the belated payment of the terminal benefits.



5. With the above direction, the Writ Petition stands disposed of. There shall be no order as to costs.
