ORDER

This criminal original petition has been filed by the petitioners seeking to set aside the order dated 25.01.2020 made in Cr.M.P.No.628 of 2019 in C.C.No.28 of 2016 on the file of the learned Chief Judicial Magistrate, Thiruvarur.

2. The learned counsel for the petitioners submitted that the petitioners are A1 & A2 in C.C.No.28 of 2016 on the file of the learned Chief Judicial Magistrate, Thiruvarur. The 1st petitioner company is situated at Haridwar, Uttarkhand and the 2nd petitioner (Director of 1st petitioner company) is also a resident of Haridwar, Uttarkhand State. Hence, the petitioners filed a petition in Cr.M.P.No.628 of 2018 in C.C.No.28 of 2016 praying to dispense with the presence of 2nd petitioner before the trial Court, but, the said petition came to be dismissed on 25.01.2020.
