ORDER

2.The learned Additional Public Prosecutor on instructions submitted that there are three FIRs that has arisen from the very same incident and apart from the present FIR in Crime No.347 of 2022, there are two other FIRs that are investigated in Crime Nos.345 and 346 of 2022.

3.In view of the above, this Court cannot interfere with the investigation in this FIR alone. There shall be a direction to the 1st respondent to conduct the investigation in all the three FIR in Crime Nos.345, 346 and 347 of 2022, since all the cases have arisen out of the same incident. The investigation shall be completed and final report or the
