2. Heard the learned Counsel for the petitioner and the learned Additional Public Prosecutor for the first respondent.

The contentions put forward by the learned counsel appearing on behalf of the petitioner are purely factual in nature and this Court cannot venture into conducting a mini investigation into the matter and it therefore does not fall within the ambit of its jurisdiction under Section 482 of Cr.P.C. Any finding on facts will also have a bearing on the investigation conducted by the respondent Police. It is also seen from records that the same Investigation Officer is investigating the case and counter in Crime Nos.11 and 196 of 2023 registered for the same incident happened on 12.01.2023.
