Venkatesh Prasad, Learned Counsel appearing for the Second to Fourth Respondents and perused the materials placed on record, apart from the pleadings of the parties.

Though the grievance ventilated by the Petitioner in the Writ Petition relates to refusal of the Second to Fourth Respondents to furnish copies of the entries made in the M-Book maintained by them, which has become redundant by passage of time, Learned Counsel for the Petitioner seeks permission of the Court to withdraw this Writ Petition reserving the right of the Petitioner to work
