2.Mr.G.Ameedias, learned Government Advocate takes notice for the respondents 1 and 2 and made a statement on instructions that due to on going Metro Phase – II work, traffic has been diverted and some temporary arrangement has been made and that there is no plan for putting up a permanent bus stop at the said place.

3.The said statement of the learned counsel for the respondent is now recorded.

4.It may have to be stated when a development activity of the magnitude of a metro takes to happen, there will be certain inconvenience, which every citizen may have to feel. After all, it is intended for the development of citizen and the citizen may have to show some degree of patience and magnitude in accepting to this.

5.The only point now remains is where to fix the board to indicate the bus spot. This is something which the concerned Authority has to decide based on a field inspection.
