We have heard Mr.M.Loganathan, learned counsel for the petitioner, Mrs.R.Anitha, learned Special Government Pleader for the respondents 1, 2, 4, 6 and 7 and Mr.N.R.R.Arun Natarajan, learned Special Government Pleader (HR & CE) for the respondents 3 and 5.

2. The petitioner alleges encroachment in the government lands.
