Prayer: Plaint has been filed under Order IV Rule 1 of Original Side Rules read with Order VII Rule I of Civil Procedure Code, 1908 and Section 7 of the Commercial Courts, Act 2015, to grant a judgement and decree on the following terms:-



a) For recovery of a sum of Rs.4,93,18,575 (Rupees Four Crores Ninety Three Lakhs Eighteen Thousand Five Hundred and Seventy Five Only) together with interest at 24% per annum on 3,52,00,000/- (Rupees Three Crores and Fifty Two Lakhs Only) from the date of plaint till the date of realization;
