Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus to call for the entire records relating to the petitioner's husband detention under Tamil Nadu Act 14 of 1982 vide detention order dated 18.08.2022 on the file of the second respondent herein made in proceedings Memo D.O.No.C2/41/2022, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's husband namely Logidass S/o.Murugan, aged 29 years before this Court and set the petitioner's husband at liberty from detention, now the petitioner's husband detained at Central Prison, Cuddalore.
