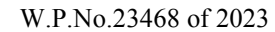

2.It is the case of the petitioners that they were appointed as Assistant Surgeon under 10(a)(i) and 17(1) in the Tamil Nadu Government Service in the year 2017 and later, qualified in Special Qualifying MRB Examination held on 28.05.2022, which was supposed to be conducted in 2019, but got delayed due to Covid-19 Pandemic. It is the grievance of the petitioners that they ought to be regularised with effect from the date of their appointment on par with other Medical Officers appointed through TNPSC/MRB (2009, 2016, 2017 and 2018). In this regard, the petitioners have also submitted their representation on 20.07.2023. Since the same was not considered, the present writ petition has been filed.

3.Heard the learned counsel for the petitioner.

4.Mr.P.Baladhandayutham, learned Special Government Pleader, who takes notice for the respondents, fairly submitted that the respondents will pass appropriate orders on the representation submitted by the petitioners.
