2. It is the grievance of the writ petitioner that the petitioner's father died in the year 1994 and immediately her mother given an application for compassionate appointment. Thereafter, the terminal benefits were settled only in the year 2003 and the petitioner had attained majority and made further representation seeking compassionate appointment. However, the same is not considered. In this regard, she has given a fresh representation dated 15.06.2023, which has also not been considered. Hence, this writ petition.

3. Heard both sides and perused the materials placed on record. It is also brought to the notice of this Court the communication issued by the respondent in க.எண்.10420/மே.பொ/திமலை/நிபி3/உதவி-2/கோ.5(94)/97 dated 30.12.1996 seeking for certain documents from the mother of the petitioner for the compassionate appointment.
