ORDER

The petitioner has applied for an electricity connection and seeks a direction to the 4th respondent to consider her application.

2.Mr.L.Jaivenkatesh, the learned Standing Counsel for TNEB, on behalf of the respondents, takes notice and makes a statement, based on instruction, that the petitioner's application was cancelled by the 4th respondent on 19.07.2023. The cancellation was due to a discrepancy between the name of the applicant and the tax receipts he had provided. Additionally, the petitioner also seeks a commercial service connection, which requires few other formalities to be completed.
