2.The grievance of the Writ Petitioner is that the petitioner was appointed as Secondary Grader Teacher and thereafter, transferred to the 3rd respondent School on 03.06.2015. After obtaining the necessary permission, the petitioner has completed M.Sc., and B.Ed., through distance education in Periyar University, Coimbatore and the same were recorded in the Service Register. While that being so, the petitioner has given representation on 13.01.2023 for grant of incentives for acquiring higher qualification, however, the same has not been considered. Hence, seeks direction of this Court.

3.Heard the submissions of the learned counsel for the petitioner and the learned Government Advocate appearing for the respondents 1 and 2.
