Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus to call for the entire records relating to the petitioner's husband detention under Tamil Nadu Act 14 of 1982 vide detention order dated 28.07.2023 on the file of second respondent herein made in proceedings Memo C.No.01/B.M./IS/Tiruppur City/2023, quash the same as illegal and consequently, direct the respondents herein to produce the petitioner's husband namely, Karthikeyan, son of Gopalakrishnan, aged 32 years before this Hon'ble High Court and set the petitioner's husband at liberty from detention, now the petitioner's husband detained at Central Prison, Coimabtoe.
