2. Directions are sought to remove the encroachment made by the fourth respondent in the Muthumariamman Temple land to an extent of 7½ acres comprised in S.No.14/12 situated at Sakkilipatti Village.

3. Upon instructions of the Tahsildar, learned State Government Pleader submits that the subject writ land is not a temple land and the same is classified as a Village site - Natham poramboke. A house patta has been granted to the fourth respondent in S.No.14/51 to an

extent of 0.25 sq.m.
