In view of the limited prayer made in this writ petition, without expressing any opinion on the merits of the claim made by the petitioner, this Court is inclined to issue a direction to the 5th respondent to consider the online application submitted by the petitioner dated 08.02.2023 and pass final orders on merits and in accordance with law after issuing notice to the respondents 7 & 8 within a period of eight weeks from the date of receipt of a copy of this order.
