The learned Additional Public prosecutor submitted that the statement of the petitioners will also be recorded under Section 161 of Cr.PC, after receiving complaint from them.

3. In view of the above submission, there shall be a direction to the Inspector of Police, DCB, Chennai to receive the complaint from the petitioners and to record their statement under Section 161 of Cr.PC and collect the relevant materials from the petitioners in the course of investigation.

4. This Criminal Original petition is disposed of with the above directions.
