ORDER

This Writ Petition has been filed for a direction to the respondent Police to give Police protection to the petitioner in order to enable the petitioner to fence his property based on the representation, dated 18.05.2023.

2. The learned Additional Public Prosecutor, on instructions, submitted that earlier, a complaint was given before the Pennagaram Police Station and it was enquired in C.P.No.0095 of 2023 and it was closed. It is further submitted that the jurisdictional Police is the second respondent and hence, if the petitioner gives a complaint in person before the second respondent, the same will be dealt with in accordance with law.

3. In the light of the above submission, there shall be a direction to the petitioner to give a complaint before the second respondent in person and the second respondent shall deal with the same on its own merits and in

accordance with law and shall enquire the parties and take a decision within a period of four weeks from the date of receipt of the complaint from the petitioner.
